




Figure 1. Static Characteristic




Figure 3. Base-Emitter Saturation Voltage Collector-Emitter Saturation Voltage




Figure 5. Derating Curve of Safe Operating Area




Figure 2. DC current Gain




Figure 4. Safe Operating Area






Figure 6. Power Derating
